

Privacy statement

Purpose of this statement

Your privacy is very important to us. We will handle your personal data with the utmost care and in accordance with the law. This privacy statement will provide a brief overview as to why, when and how we process your personal data.

i. **Controller**

The data controller who is responsible for the processing of your personal data is the private company with limited liability Claims Funding Europe Limited, with its office at Hamilton House, 28 Fitzwilliam Place in Dublin, Ireland.

ii. **Purpose of and legal basis for processing**

Claims Funding Europe Limited will process your personal data for all matters related to the rights against Steinhoff International Holdings N.V. and other parties involved (together “**Steinhoff**”) that you aim to assign to a SPV that will initiate proceedings against Steinhoff. We will, amongst others, use your personal data in order to (i) verify your identity in the context of entering into the assignment agreement and (ii) evidence the validity of the assignment agreement in court proceedings against Steinhoff.

Legal grounds for the processing by Claims Funding Europe Limited of your personal data include the enforcement of the assignment agreement, the representation of the SPV’s legitimate interests as assignee and Claims Funding Europe Limited’s compliance with statutory obligations. Claims Funding Europe Limited’s legitimate interests in this context consist of enforcing the assigned rights against Steinhoff.

iii. **What personal data is processed**

We collect the following personal data:

- Name, surname;
- Address; and
- Any other personal data relevant in relation to the purposes stated in section ii above.

Claims Funding Europe Limited obtains your personal data because you disclose this information yourself.

iv. **Recipients of personal data**

Claims Funding Europe Limited will not share your personal data with third parties, unless this is necessary in relation to the processing purposes stated in section ii above. In the context of court proceedings for example your personal data may be shared with the court, counterparties and their advisors/ counsel.

v. **Retention period**

Claims Funding Europe Limited will retain your personal data no longer than necessary for the processing purposes stated in section ii and will in any event erase your personal data no later than two years after the court proceedings against Steinhoff have ended.

vi. Your rights

As a data subject, you have the right to request Claims Funding Europe Limited provide you with access to the personal data that is being processed, rectify your personal data if the personal data that is processed turns out to be incorrect, incomplete or irrelevant and restrict the processing of your personal data. You also have the right to object to the processing of your personal data and to request for erasure of your personal data as well as the right to data portability.

You also have the right to lodge a complaint with the Dutch Data Protection Authority (*Autoriteit Persoonsgegevens*) with regard to the processing of your personal data: <https://autoriteitpersoonsgegevens.nl/en>.
